  - 4. A word about jurisdictions. Colossians 1:9-14. In its most technical sense, a jurisdiction is a place or territory from which justice or righteousness is administered. This place is the Kingdom of God.
  - 5. Freedom is based on truth and if one is convicted of truth and acts on it, that truth will ALWAYS ENFORCE FREEDOM! John 8:31-32.
- II. When one is made free, he or she must learn how to keep that freedom. There will always be someone or some force that will attempt to bring one back into bondage.
  - 1. Israel's deliverance from Egypt. Exodus 14.
  - 2. America's independence. Benjamin Franklin. "A republic...if YOU can keep it!"
  - 3. The 14th Amendment: bondage, not freedom.
- III. Three Responsibilities of Freedom.
  - 1. Obedience to God. Exodus 20:1-11; John 14:15; 15:10-12.

- 2. Respect for others, their rights and what belongs to them. Exodus 20:12-17; Romans 13:8-10; 1 Thessalonians 4:6-7; John 13:34-35; 1 John 3:16-24.
- 3. Self Government. Galatians 5:13, 22-23; 2 Peter 1:6; 1 Thessalonians 4:9-10; John 13:34-35.
- IV. Imagine life on this land called America with all people living by the Bill of Rights.

#### II. Four Major Responsibilities of Freedom.

- 2. Respect for others, their rights and what belongs to them.
- 3. Self Government. Romans 6:12-19.
- 4. That we teach others how to walk in freedom. Matthew 28:19-20; Matthew 5:14-16.
- III. Why has satan had such success in keeping people in the Church and America in bondage? Nine things satan is banking on:
  - 1. Your lack of knowledge of the Father's plan for you, the Church and America. Ephesians 1:9-10; Psalm 33:12.

- 2. Your continuance in yielding to distractions. Mark 4:18-19 Amplified; Isaiah 55:1-3.
- 3. Your continued laziness and refusal to read and educate yourself. Proverbs 18:15; Proverbs 6:6-11.
- 4. Your self centeredness. 2 Timothy 3:1-2; Philippians 2:19-21.
- 5. Your love of pleasure more than loving God. 2 Timothy 3:4.
- 6. Your procrastination. Ecclesiastes 10:18.
- 7. You continuance in making "majors out of minors." Philippians 1:9-11 Amplified.
- 8. Your continued focus on "making it" and trying to "get ahead" in life. Matthew 6:24-34.
- 9. Your fear of accepting personal responsibility. Philippians 2:12-16; James 1:22; Proverbs 22:3.

#### IV. Come Out of Her! Revelation 18:1-4; 2 Corinthians 6:14-18.

- 1. There is a global, satanic structure, (kosmos: "orderly arrangement") with an agenda to enslave every man, woman, boy, girl and nation and it is in serious operation on our soil. Its enslavement is carried out through laws, ordinances, usury, surety, sorcery, government, your signature, finances, etc. It is a "spiritual jurisdiction" expressed in the natural world through these avenues. #### II. What is a "jurisdiction?"

- 1. In its most literal and technical sense, it is the place from which law is pronounced (from "juris", law and "dictio", to pronounce). It is [meant to be] the place from which justice or righteousness are to be declared.
- 2. In its most general sense, it is the place in which resides the power to govern, legislate or exercise authority.
- 3. In reality, there is <u>only one true jurisdiction</u>, the Kingdom of God, with Him as the King. <u>Psalm 103:19</u>; <u>Jeremiah 10:7-10</u>; <u>Isaiah 9:6-7</u>.
- 4. The Kingdom of God, "de jure"; the authority of darkness, "de facto." "...for when the de jure is in operation, the de facto must go away."
- 5. "De jure", "De facto", defined in Black's Law Dictionary, Sixth Edition.
- III. Herein rests the major problem: because the "True Church" and the individual Believer, for the most part, have not understood our jurisdiction, (the Kingdom of God), satan has, through our default, been able to govern our affairs, the affairs of men and the affairs of nations...UNJUSTLY!

- 1. Our "citizenship" (politeuma, 4175 Strong's/Vine; commonwealth; manner of life; community; heavenly status as Believer's) is in heaven and we are to BRING HEAVEN TO EARTH! Philippians 3:20; Philippians 1:27; Matthew 6:9-10; 18:18-20 Amplified Bible; Mark 16:15-20. "...for when the de jure is in operation, the de facto must go away!"
- 2. "It is written!" Matthew 4:1-11: "...for when the de jure is in operation, the de facto must go away!"
- 3. Isaiah 55:11. "...for when the de jure is in operation, the de facto must go away!"
  - 1. A clash of kingdoms. Acts 17:5-7.
- IV. If we will search the Scriptures, we will find a clear picture as to what is going on in our nation and the nations of the world. The Father did something with America that no other nation, not even Israel was willing to accept His call for. We are going to find out and/or have confirmed to us that we cannot sit idly by and allow what the Father gave us for ourselves and the nations of the world to be stolen. IT IS ALL ABOUT THE KINGDOM OF GOD!

- a) God's righteousness, in Christ. 2 Corinthians 5:21; Isaiah 54:17.

- I. We must prepare ourselves for the greatest adventure in mind renewal that will take place in our lives on this side of the future glory. Romans 12:1-2.
  - 1. <u>Concordant Literal Translation</u>: "I am entreating you, then brethren, by the pities of God, to present your bodies a sacrifice, living, holy, well pleasing to God, your logical divine service, and not to be configured to this con, but be transformed by the renewing of your mind, for you to be testing what is the will of God, good and well pleasing and perfect."
  - 2. We are living in a time of <u>FULL DISCLOSURE</u> on our land. Things are being revealed so that people can make decisions based on full and accurate knowledge.
- II. Coming out and spiritual jurisdictions. It's Light vs. darkness; Elohim vs. satan; law vs. lawlessness; righteousness vs. unrighteousness; love and faith vs. fear and hate.
  - 1. Legally and lawfully, we have been delivered from the authority of darkness and placed into the Kingdom of the Father's Dear Son!
  - 2. We are not mere subjects of this Kingdom; we are owners of the Kingdom. We are "heirs of God and joint heirs with Christ." Luke 12:31-32; Romains 8:16-17.
  - 3. We've been given the Name of Jesus, the Word of God and the Holy Spirit.
  - 4. We must learn how to "vitally" function according to the principles of the Kingdom of God. We are free, however, if we step outside of our heavenly jurisdiction, or don't understand the laws and principles and how to live in them, we become vitally subject to the principles of darkness.

Once we correct things, darkness has NO AUTHORITY TO BIND US! The same applies for us on this land as Americans. We must learn and operate in our jurisdiction here, too! Remember: "when the de jure is in operation, the de facto must go away."

- III. Our God is a King with a kingdom. Psalm 103:19.
  - 1. King dom; a sovereign over a domain.

  - 1. Man under God and His government alone.

  - 2. All of this is expressed in the Law of Moses and the Commandment of the Lord Jesus. John 13:34-35; 1 John 3:22-24.
    - a) Obey and honor the Lord.

- III. What indications do we have that show us that there are two jurisdictions on this land called America?

- 1. The Declaration of Independence vs. The District of Columbia Act of 1871/UNITED STATES CORPORATION ARTICLES OF INCORPORATION 1925.
  - a) "united States of America" on the Declaration of Independence. The name of our country is "America."
  - b) UNITED STATES CORPORATION COMPANY. Articles of Incorporation filed in the State of Florida, July 15, 1925. IT IS NOT A GOVERNMENT.
    - 1. Title 28 USC 2002 Section 15: "United States means (A) a Federal corporation.
    - 2. UCC 307h: The United States is located in the District of Columbia.
- 2. There are two flags on the land.
  - a) The Flag of the Republic; red, white and blue. Here, America's Constitution (The Constitution <u>for</u> the united States of America) and Bill of Rights is respected.
  - b) The Flag of THE UNITED STATES CORPORATION: a red, white and blue flag with a gold fringe. This is a Military, Admiralty, Martial Law flag. It is another jurisdiction and is seen in the majority of the courts and "government" buildings on the land.
- 3. An American ("state" Citizen) vs. U.S. Citizen.
  - a) USC 1101 (a)(21). The term "national" means a person owing permanent allegiance to a state.)
  - b) USC 1101 (a)(22). The term "national of the United States" means (A) a citizen of the United States, or (B) a person, who, though not a citizen of the United States, owes permanent allegiance to the United States.
  - c) Contract Law a vital element.

### Come Out of Her! XII "Two Jurisdictions In Law: How Do We Know?" III

Colossians 1:12-14 Revelation 18:1-4

- I. Jurisdictions: something we must understand. This Scripture is part of the prayer of Colossians 1:9ff.
  - 1. Spiritually, it's the Kingdom of God's Dear Son vs. the authority of darkness.
  - 2. On our land, it's the Republic vs. THE UNITED STATES CORPORATION.
  - 3. What is on our land that is unique is the fact that there are two jurisdictions in law. It is an exact mirror of what is in the spirit realm anyone can choose which one he or she will be in.
  - 4. This is beyond "politics"; it is a conflict of kingdoms.
- II. "Come Out!" is a word from the Lord that requires obedience. We come out:
  - 1. Morally.
  - 2. Jurisdictionally.
  - 3. Jeremiah 51:6-9: "go everyone into his own country."
  - 4. "...and accordingly all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed." The Declaration of Independence.
  - 5. Will we break the "normal" pattern of mankind or accept the individual responsibility to change? Each of us must answer for ourselves.
- III. What indications do we have that reveal to us that there are two jurisdictions on this land called America?
  - 1. The Declaration of Independence vs. The District of Columbia Act of 1871/THE UNITED STATES

### CORPORATION – ARTICLES OF INCORPORATION 1925.

- 2. There are two flags on the land: The Flag of the Republic and the gold fringed flag.
- 3. An American ("state" Citizen) vs. a U.S. citizen.
- 4. The "money" on our land.
  - a) Our Constitution says in Article I, Section 10 that "no state shall make any Thing but gold and silver Coin a Tender in payment of Debts."
  - b) Our Constitution says in Article I, Section 8 that "Congress shall have the Power To...coin Money, regulate the Value thereof, and of foreign Coin, and fix the Standard of Weights and Measures; To provide for the punishment of counterfeiting the Securities and current Coin of the United States.
  - c) Black's Law. Money defined. "In usual and ordinary acceptation it means coins and paper currency used as circulating medium of exchange, and does not embrace notes, bonds, evidences of debt or other personal or real estate. Lane vs. Railey, 280 Ky. 319, 133 S. W. 2d 74, 79, 81."
  - d) The Coinage Act of 1792. The Dollar would be the standard of weights and measures and be redeemable for 1/20th ounce of gold and .7734 ounces of silver.
  - e) Federal Reserve" Notes." This is not money.
  - f) Where is the gold and the silver? Haggai 2:6-9; Proverbs 28:8; Ecclesiastes 2:26.

- II. "Come Out of Her (Babylon), My people!" is a word from the Lord to be "honored." What IS Babylon? The Scripture refers to her as "MYSTERY BABYLON." Revelation 17:5. Some elements of the "Mystery."
  - 1. Man, a key figure in the kingdom conflict. Genesis 3:1-15.
  - 2. Nimrod and the Tower of Babel. Genesis 11:1-9. A "key" attempt by Lucifer to "use" man to establish a kingdom, a system, a cosmos, an order through which he is worshipped as "god."
  - 3. Nebuchadnezzar's dream. Daniel 2.

  - 4. Understand what represents THE UNITED STATES CORPORATION, its fraud and deception and its role in modern day Babylon.
  - 5. Commit to searching out every way of detaching yourself from the fraud, deception and ungodly deeds of modern day Babylon and its demonic spirits.

  - 2. A constant barrage of fear. 2 Timothy 1:7; Romans 8:15; Psalm 118:6. We cannot constantly feed on things that will give the spirit of fear an advantage over us!
  - 3. A constant barrage of lawlessness, offences, selfishness and a lack of both "common and spiritual sense." Matthew 24:10-12; 2 Timothy 3:1-5 Romans 1:18-32; 2 Thess.2:11.
  - 4. A constant barrage of tests and trials. James 1:2-4. This references the enemy "testing" your faith through adversity.
  - 5. Distractions. Mark 4:19.
  - 6. Environmental toxins, "deceitful" food and lack of proper nutrition. 1 Thessalonians 5:23. Drink pure water, clean up your diet and exercise!
- II. We must RESOLVE to be MORE DETERMINED TO BE STRONG AND INCREASE IN STRENGTH THAN satan is to wear us out! Daniel 11:32.
  - 1. Assume an offensive posture! Declare and do! Practice dealing the first blow rather than practicing responding after being hit! Acts 10:38; 2 Corinthians 2:14. Constantly remind satan of his past, present and future! Colossians 2:13-15; Ephesians 1:19-23; Romans 16:20; Revelation 19:20; Revelation 20:10.

- 2. Make feeding on the Word, obedience to that Word and communion with the Holy Spirit "THE" PRIORITY OF YOUR LIFE! Proverbs 8:34-36; John 14:26; 16:13-15.
- 3. Master the "Endurance Process!" James 1:2-4; 1 Peter 5:8-11.
- 4. "My strength comes from the Lord!" Philippians 4:13; Ephesians 6:10; Psalm 27:1-3.

# <u>Come Out of Her! XV</u> "<u>Freedom vs. Slavery: What's YOUR Mentality?</u>" I John 8:28-44

#### I. What are they?

- 1. Freedom; Webster's 1828 Dictionary: "A state of exemption from the power or control of another; liberty; exemption from slavery. (free dom = liberty to exercise dominion).
- 2. Slavery; Webster's 1828 Dictionary: "...the obligation to labor for the benefit of the master, without the contract or consent of the servant.
- 3. One can be in slavery and not even recognize it! John 8:33-36.
  - a) Rome.
  - b) Their "father, the devil."
  - c) A handful of "benefits", usually in the forms of food, clothing and shelter, can give to one the "appearance" of liberty.
- 4. Freedom comes and is maintained through a consistent abiding in and intercourse with the truth. Abiding in liberty is not automatic. There will always be some force attempting to enslave you! John 8:31-32.
- II. The Body of Christ MUST grow in its understanding of the intermingling of the spiritual realm with the kingdoms of this world. Daniel 10; Hebrews 11:32-33; Revelation 11:15. If a Believer claims to be "kingdom minded", then he or she must understand this and that the conflict for the eternal spirits, souls AND BODIES of men is inseparable from the conflict for nations.
  - 1. Man's history is a history of wars and their "luciferinspired desire to dominate and enslave one another. Because of the subtlety of the "dragon-serpent", most have missed this where America is concerned.

- III. The "American Experiment." The Declaration of Independence, July 4, 1776 and The Bill of Rights, December 15, 1791. It does not appear that ANYTHING like this was ever done in the history of men and governments.
  - 1. The sole purpose of "government" was to protect and secure the "unalienable", Creator given rights of the people.
  - 2. The original intent of the Constitution and the Bill of Rights was to keep government from overstepping its boundaries. IT WAS NOT TO CONTROL THE PEOPLE!
- IV. satan has gradually and cleverly woven into the fabric of America a "system" that obscured the Republic and enslaved EVERYONE who didn't recognize what was going on. It is what we are dealing with right now. The system consists of two major elements and how we deal with them: a debt/surety based system and contracts.
  - 1. Debt and surety. Proverbs 22:7; 6:1-5; 11:15; 17:18; 22:26-27. Surety; the pledge, the security, the guarantee for the debt of someone else.
  - 2. Contract law; covenant.
  - 3. Revelation 18:1-4.

  - 3. Parkfield Community School, Birmingham, England.
- III. How will YOU measure? Mark 4:22-24 Amplified.
  - 1. Your spiritual "jurisdiction." Colossians 1:12-14.
  - 2. Your American "jurisdiction." The Declaration of Independence and The Bill of Rights.

    - a) The King of kings.

  - 4. Lacking understanding of this is what makes it difficult for us to understand what true government is supposed to be. Deuteronomy 16:18-20. The Declaration of Independence. When America won its independence, the "crown of sovereignty" was passed from the king of England to the State Citizen.
  - 5. The Bill of Rights and the Constitution for The united States of America were for the purpose of limiting the control of government over the lives of the people.
- II. There are two jurisdictions, in law, on this land.
  - 1. The Republic. This one is for God, freedom and liberty.
  - 2. The UNITED STATES CORPORATION. This one is for bondage, debt and slavery.

- I. Lawful vs. Vital Aspects of Redemption. We ARE FREE! Romans 8:1-2. However, in a vital sense, many times we "contract away" our freedom through what we say and what we do.
  - 1. What we affirm (say). Hebrews 3:1; "profess." Homologeo; 3670; Strong's/Vine; to speak the same thing; to agree with; to speak out freely or to declare openly as a result of an inward or deep conviction of the facts.
  - 2. What we do: the actions of our lives. James 1:22-27.
- II. We are called to liberty (freedom). Galatians 5:13; John 8:36.
  - 1. Sovereignty: free right and power to govern oneself without interference from outside forces.
  - 2. The Lord gave man sovereignty, through his disobedience death "seized" it, The Father's free gift of righteousness retrieved it for us.
  - 3. Righteousness is required for self government. 1 Timothy 1:5-11; Matthew 22:34-40 (Deuteronomy 6:5; Leviticus 19:18).
- III. The Lord deals with nations; what they stand for is of the utmost importance to Him. Psalm 33:12; Matthew 25:31ff.
- IV. For us to reclaim both our freedom and our nation, we must go back to the foundation; the original intent and purpose. We must then see where we are now. Then, we must pay the price to reclaim what was lost.

- V. A "system" was cleverly designed by satan to defraud the people out of their freedoms and privileges through them contracting them away. The Constitution for the united States of America is the "supreme Law of the Land" and contract law is binding (Article VI).
  - 1. State of the Union Citizen vs. UNITED STATES CITIZEN.

- I. We are called to freedom! However, there are forces at work that want to keep us from walking in that liberty and have the notion that we should be slaves. Slavery can be:
  - 1. By coercion.
  - 2. By choice.
  - 3. By fraud (i.e. by deliberate deception for the purpose of depriving another of their lawful rights).
  - 4. By debt. Proverbs 22:7.

#### II. What is the purpose for government?

- 1. In the "Household of Faith" it is for the purpose of:
  - a) Giving direction. 1 Corinthians 12:27-28; 1 Timothy 3:1-7; 5:17-18.
  - b) To promote growth and maturity amongst the saints. When one understands love (giving, serving, unselfishness, forgiving), one understands freedom. As a result, we will love God and honor mankind. Ephesians 4:11-16; John 13:34-35.
- 2. Two requirements for church leadership:
  - a) The Anointing. 2 Corinthians 1:21; 3:5-6.
  - b) Personal maturity. 1 Peter 5:2-3.
- 3. For the punishment of evildoers. Romans 13:3; I Timothy 1:5-11. The ungodly must be "checked."
- 4. The Declaration of Independence. The "security" of Life, Liberty and the Pursuit of Happiness. The protection of the people and their God given rights.

#### III. Some important quotes.

- 1. "The only thing necessary for the triumph of evil is for good men to do nothing." Edmund Burke.
- 2. "Those who profess to favor freedom, yet deprecate agitation, are men who want crops without plowing the ground. They want rain without thunder and lightening. - III. How does The High Priest expect His tithe to be administered?

  Malachi 3:10. The Lord wants "meat" in His house (meat is provision; resource; fruit). For what?
  - 1. **Deuteronomy 26:12-14**. The Levite, the stranger, the fatherless and the widow.
  - 2. **Deuteronomy 14:22-29**. The Levite, the stranger, the fatherless, the widow and whatsoever your soul desires.
  - 3. Always at the place at which "the Lord your God shall choose", not according to our own terms.
  - 4. The tithe is holy; that is, it is set apart for the purposes that He has designed it for. Leviticus 27:30-34.

- IV. A very significant factor in the revivals of Israel in their history was the re-instituting of the first fruits and the tithes among the people; e.g. 2 Chronicles 29-31: the reign of King Hezekiah; Nehemiah's rebuilding campaign: Nehemiah 10:35-39.

Part of this Act stated: ... "The President may investigate, regulate, or prohibit, under such rules and regulations as he may prescribe, by means of licenses, or otherwise, any transactions in foreign exchange, export or earmarkings of gold or silver coin or bullion or currency, transfers of credit in any form (other than credits relating solely to transactions to be executed wholly within the United States)." The citizens of the united States were excluded from this; they were not considered the enemy.
- 2. 1920 The Independent Treasury Act turned the American Treasury Department over to the Federal Reserve.
- 3. 1921 The Council on Foreign Relations was formed to direct the media.
- 4. 1925 THE UNITED STATES COMPANY filed "perpetual" Articles of Incorporation.
- 5. 1925 The Federal Reserve Bank has two offices located in New York City.
- 6. The "Depression" of the late 1920's-early 1930's created a "national emergency."
- 7. The United States declared bankruptcy, March 9, 1933.

- 8. Article I, Section 9 of the Constitution states that, "The Privilege of the Writ of Habeas Corpus shall not be suspended, unless when in Cases of Rebellion or Invasion the Public Safety may require it." In essence, this means that the government could not suspend due process of law or operate its arbitrary prerogative of power over We The People, unless there was a "state of emergency." This is the only way that the Constitution could be set aside. If something ever happened to cause the Constitution to ever have to be put aside, it was to be returned to its peacetime authority once the crisis was over.
- 9. After Franklin D. Roosevelt was inaugurated President in 1933, there was put into place the "Emergency Banking Act" along with President Roosevelt asking Congress for the "rule of necessity" (i.e. necessity knows no law) and "The War Powers Act" (an amending of the Trading With The Enemy Act, 1917).
- 10. "Be it enacted by the Senate and the House of Representatives of the united States of America in Congress assembled, That the Congress hereby declares that a serious emergence exists and that it is imperatively necessary speedily to put into effect remedies of uniform national application."
- 11. "During time of war or during any other period of national emergency declared by the President, the President may through any agency that he may designate, or, otherwise, investigate, regulate, or prohibit, under such rules and regulations as he may prescribe, by means of licenses or otherwise, any transactions in foreign exchange, transfers of credit between or payments by banking institutions as defined by the President and export, hoarding, melting, or earmakings of gold or silver coin or bullion or currency, by any person within the (united

<u>States) or anyplace subject to the jurisdiction thereof.</u>" Amended Act of October 6, 1917.

  - 1. Our goal as "Kingdom Saints" should be to come out of and avoid every form of debt, usury and surety. Romans 13:8; Deuteronomy 28:1-2, 12-13, 43-44; Proverbs 11:15; 17:18; 6:1-5.
- IV. Why "in the world" are we giving and tithing?
  - 1. It should be to receive The Lord, The Great King as our only Source of Supply. Malachi 3:10-12; Proverbs 3:9-10; 2 Corinthians 9:6-15; Mark 10:29-30.
  - 2. We must "sell out" to Kingdom "Promises.

# "Come Out of Her!" XXVI "The Debt Curse of 1933" I

# Romans 12:1-2 Barclay, Cottonpatch, Phillips, Wuest 2 Timothy 1:7 Amplified

- I. Mental "toughness"...a necessity in these times.
- II. Our Lord is The King Who shares His Kingdom with His people. Psalm 89:18; 103:20; Luke 12:31-32.
  - 1. Psalm 24:1.
  - 2. Psalm 115:15-16.
  - 3. Hebrews 1:1-2.
  - 4. Romans 8:16-17.
  - 5. Romans 8:31-32; 1 Corinthians 3:21-23.
- III. Usury (debt with interest) and surety were never meant by the Father to be for His people. They are forms of bondage and oppression. Debt could be used by His people to encourage the heathen to come into the Kingdom of God. Instead, satan has flipped it and used it as a tool to control people through bondage and oppression and to be a "pseudo-provider" to mankind. Deuteronomy 28:12-13, 15, 43-44.
  - 1. The members of the Father's Family were <u>never</u> to lend to one another with usury. Exodus 22:25-27; Leviticus 25:35-38; Nehemiah 5:1-13.
  - 2. A "stranger" or, a non covenant man could be charged interest by God's people. Deuteronomy 23:19-20.
  - 3. There were consequences and penalties for violating the Lord's principles of usury. Proverbs 28:8; Ezekiel 22:12-13.
  - 4. A contract/covenant is made when one agrees with another to be the supply of their need or desire. When this occurs with the ungodly as the head and a Believer as the tail, a confusing covenant bond is formed.

- IV. Surety; suretiship. <u>Webster's 1828 Dictionary</u>; the obligation of a person to answer for another, and make good any debt or loss which may occur from another's delinquency. In law, one who is bound with and for another; one who enters into a bond or recognizance to answer for another's appearance in court, or for his payment of a debt or for the performance of some act, and who, in case of the principal debtor's failure, is compellable to pay the debt or damages.
  - 1. This is to be avoided and hated by God's people. Proverbs 6:1-5; 11:15; 17:18; 22:26; 27:13.
  - 2. Jesus Christ, the "Surety" of a "better covenant." The one act of suriteship that pleased The Father. Hebrews 7:22; Romans 4:25; 2 Corinthians 5:14-21.

#### <u>Come Out of Her!</u> XXVII "<u>The Debt Curse of 1933</u>" II Romans 12:1-2

- I. We must prepare ourselves for change in our thinking. There are things that we thought were and we will find out that they are not as we thought they were. We must also prepare ourselves to accept responsibility for:
  - 1. Our health.
  - 2. Our freedom.
- II. satan is a deceiver. John 10:10; Revelation 20:6-10.
  - 1. He moves upon men and the governments of this world to "dismiss" the Lord from their ruling. Psalm 2:1-12; 12:1-4.
  - 2. He is a fraud. Psalm 10:4-7; James 5:1-4. "Fraud" defined; Webster's 1828 Dictionary; deceit; deception; trick; artifice by which the right or interest of another is injured; a stratagem intended to obtain some undue advantage; an attempt to gain or the obtaining of an advantage over another by imposition or immoral means, particularly deception in contracts, or bargain and sale, either by stating falsehoods, or suppressing truth.
- III. It is a MUST that we understand two facts about what is in place on America:
  - 1. That there are two jurisdictions IN LAW.
  - 2. That our allegiance to one jurisdiction or the other is determined by which one we contract with.
  - 3. Grasping these two things will help us to know what it means to Come out of Babylon according to Revelation 18:1-4 and 2 Corinthians 6:14-18.
  - 4. There are a multitude of distractions set up by the deceiver to keep people from focusing on these facts.

- IV. The UNITED STATES CORPORATION filed bankruptcy in 1930. Through a series of acts and "corporate" developments from c. 1913-1938 ff (The Federal Reserve Act, WWI, The Independent Treasury Act, Formation of the Council on Foreign Relations, The UNITED STATES CORPORATION COMPANY, the amending of the Trading With The Enemy Act, The Emergency Banking Act, The Social Security Administration Act, The Buck Act, Birth Certificates, required licensing, gradual changes in the Supreme Court, the introduction of The UCC (Uniform Commercial Code), etc.), the American people, their posterity, lands, farms, houses, wealth, etc. were "set up" to become the surety for the debt of the UNITED STATES CORPORATION to the Federal Reserve.
  - 1. The UCC became the "Law of the Land", replacing the Constitution, common law, previous Supreme Court decisions (that were discarded and no longer to be used as precedent). It was the introduction of corporate contract law, statutes and codes, Public Policy. It is the means through which this bankruptcy is administered and the people of the land, through signature and agreement to various contracts and benefits, become the surety for the debt through their work efforts.   - 2. What is the solution? Recapturing of our signatures from things that we unknowingly signed, agreeing to be a U.S. citizen and learning how to sign contracts from the present onward.
  - 3. THE FRAUD runs VERY DEEP and it invades all areas of life: bank accounts, various forms of registration, Driver's License, various forms of taxes, courts, lawyer's, attorney's, on and on and on....
  - 4. Slavery or freedom...which will we choose?

- I. Why are we looking at this?
